The undersigned **Zenith Asset Management Zártkörűen Működő Részvénytársaság** (company registration number: Cg.01-10-143055; registered office: 1056 Budapest, Váci utca 38.; hereinafter referred to as "**Zenith Asset Management Zrt.**") hereby informs you of the following in accordance with Section 61 (1) of Act CXX of 2001 on the Capital Market (hereinafter referred to as "**Capital Market Act**"):

Magyar Bankholding Zrt. (hereinafter "**MBH Zrt.**") was dissolved on 30 November 2024 and was replaced on 1 December 2024 by ten successor companies – including Zenith Asset Management Zrt. – among which a total of 318,883,966 series "A" ordinary shares owned by MBH Zrt., issued by **MBH Bank Plc.** (company registration number: Cg.01-10-040952, registered office: 1056 Budapest, Váci utca 38.; hereinafter: "**Issuer**"), representing 98.87% ownership and voting rights in the Issuer, were distributed. As one of the successor companies of MBH Zrt., Zenith Asset Management Zrt. acquired a total of 83,189,017 series "A" ordinary shares issued by the Issuer, representing a shareholding of 25.79% in the Issuer. Thus, the proportion of shares and voting rights of Zenith Asset Management Zrt. with direct voting rights in the Issuer increased from 0% to 25.79%* on 1 December 2024, exceeding the 5, 10, 15, 20 and 25% thresholds set out in Article 61(3) of the Capital Market Act
